


Growing Forward 2 On-Farm Energy Management Program

Energy Assessment Providers

Subject to available funding, the On-Farm Energy Management Program will share costs, up to \$9,000, with Alberta producers who have an energy assessment of their operation performed by an independent third-party assessor that is listed in this document, or otherwise pre-approved by the Program. Assessment reports are further eligible in the On-Farm Solar PV Program, for an increased incentive.

An energy assessment for your farm will give you a breakdown of what exactly happens to the energy you purchase, giving you more detail about input costs, and revealing areas of inefficiency. Some providers will include recommendations for how to improve efficiencies, and what the payback will be on equipment retrofits. Recommendations from the assessments are often eligible for funding under the On-Farm Energy Management Program.

To apply for funding towards an energy assessment, fill out an Application form for the On-Farm Energy Management Program (use *Part D* of the form). If your Energy Assessment Provider is not listed in this document below, they will need to be preapproved by the Program. They need to contact the Program at (780) 427-4181 to receive the submission criteria and process steps.



Remember that funding under the Program is not assured until you receive a Grant Approval letter.






